

LIABILITY RELEASE AND INDEMNIFICATION AGREEMENT

READ CAREFULLY – This release affects your rights!

This release is executed, by and between the undersigned individuals, hereinafter called "Driver," and the undersigned car video installation company, (**Your Store Name**) hereinafter called "**(Shortened version of Your Store Name)**".

Driver has requested that (**Your Store**) install a video player/DVD or similar equipment ("Equipment") in the front seat of motor vehicle, owned or leased by Driver. Driver is aware that having video equipment in the front seat of a motor vehicle poses a hazardous situation for the driver of the vehicle and other passengers in the car and on the roadway. Driver has voluntarily requested that such Equipment be installed in said vehicle and does hereby agree to accept any and all risks of property damage, personal injury and death that may arise from the use of the Equipment.

In consideration for having (**Your Store**) install such Equipment, Driver hereby acknowledges and agrees that the Equipment is to operate only while the vehicle is in "park" and not in motion. Driver hereby acknowledges and agrees not to tamper or have any other person tamper with any safety mechanisms (**Your Store**) has installed that prevents the Equipment from functioning while the vehicle is in motion. Driver hereby agrees and acknowledges that he/she will notify anyone else driving the vehicle of the terms of this release and the danger of using the Equipment while the vehicle is moving. Driver also understands that any safety equipment provided for his/her protection may be inadequate in preventing serious injury.

Therefore in consideration of the installation of the Equipment, Driver hereby releases and forever discharges (**Your Store**), it's employees, officers, personal representatives, successors, agents and attorneys of and from all actions, law suits, attorney fees, medical bills, expenses, costs, claims, demands, injuries, damages, liability whatsoever arising from or related to the use of the Equipment during the operation of the vehicle. This release shall be binding upon the Driver, his/her heirs, executors, administrator, assigns, and personal representatives.

In signing this release, each of the undersigned hereby acknowledges and represents:

- (A) that s/he had read the foregoing release, understands it, and signs voluntarily;
- (B) that s/he is over 18 years of age;

(C) that s/he understands that this is more than a receipt for services rendered to said vehicle, IT IS A RELEASE, GIVING UP ALL RIGHTS TO RECOVER FROM (**YOUR STORE**) IN EVENT OF INJURY OR LOSS
And assuming any and all liability from others injured by the use of the Equipment while the vehicle is moving.
